With Tiered pricing, you can use a certain amount of electricity at a lower price. Once you exceed that limit; a higher price applies.



#### **Ontario Electricity Rebate (OER)**

The OER will be reducing to 21.2% effective January 1<sup>st</sup>, 2021. The Government's intention is that, for residential and small business customers, the reduction in the electricity price will be offset by the change in the OER.

The OER is a total pre-tax credit that appears at the bottom of electricity bills. As a result of lower RPP prices and the reduced OER, typical residential customer bills will be held stable.
